Dear Green Valley Turf Co.,

Using data from Golden, CO.¹ in west Denver and published research on relative water use rate of various turfgrass species and varieties², the following lawn irrigation requirement projection is constructed.

Estimated monthly irrigation requirements are shown March-October for three scenarios:

- 1. Kentucky bluegrass lawn with typical overhead irrigation system watering to 80% of the water deficit or Precipitation –Evapotranspiration (ET).
- 2. 'Tahoma 31' hybrid Bermudagrass watered at 50% of water deficit, like what might be expected using a good overhead irrigation system.
- 3. 'Tahoma 31' hybrid Bermudagrass watered at 30% of water deficit as might be expected using subsurface emitter irrigation.
